




### Summary of Secord Lake Association April 20, 2024 Meeting

We held our first meeting of the new season on Saturday April 20th. We appreciate the positive energy and engagement that filled Secord Township Hall. We discussed our current challenges and opportunities. Attendees were provided with three handouts. The update referenced these, and we will provide the links to each below for your review. Our friend "Angry Man" made an appearance as he does with each update. He reminds us that no one asked to be in this situation. The journey to rebuild is **complex and changes**, leading to **confusion**. Confusion can lead to **frustration** and frustration can bring **anger**.

All agreed "Angry Man" had a busy winter.

One of our goals is to provide accurate, timely information to help relieve "confusion". We may not always like the news, but having updated information is preferred to not knowing.

We also discussed the dangers of Facebook with some people constantly posting things that are not true. The situation is complex enough without a handful of people purposely causing more confusion with untruths.

### FLTF?




FLTF is delegated authority of the Counties

- Board members VOLUNTEER - there is NO Compensation
- Secord has 2 FLTF Board Members
- 9 Board positions voted on by Members
  Board votes officers
- Board votes officers
  Board votes FLTF representatives
- FLTF Board interviews, screens and appoints Board Members from Recommendation
- FLTF has one County Commissioner from Gladwin and Midland
  County Commissioners are elected officials

Rumors and Nonsense "Facebook Says"



- FLTF can increase assessment 10% per year. • FALSE -- the current Operations / Maintenance 2022, 2023, 2024
  - ✓ FALSE - recently approved assessments 2025, 2026. 2027, 2028, 2029✓ Must be approved via hearing process by counties.
- FLTF pays Dave Kepler \$250,000 a year for office space.
  - ✓ FALSE - Office space, utilities and printing donated by Kepler family 2019-2023.
  - Office space is in downtown Midland / meetings with politicians and others.
  - ✓ Edenville construction trailer is **not** conducive to office employees or meetings.
- FLTF awarded a no bid contract for Operations to Dave Kepler's son.
  ✓ FALSE -- there is no contract.
  - $\checkmark$  Operations is in-house  $\rightarrow$  the pick-up trucks to transport employees and equipment
  - ✓ Dave's son has no experience or desire to be involved in the FLTF.





Phil and Chuck explained how they were appointed / elected to the FLTF Board to represent Secord. They also explained their roles and challenges on the Finance and Construction committees.

We reiterated that FLTF BOARD MEMBERS are VOLUNTEERS from each of the lakes - - they receive NO PAY, perks, or benefits.

Joel indicated that county commissioners, township supervisors and other volunteers receive no compensation, perks, or benefits from FLTF.

We then addressed three rumors that continue to be circulated by a few people on various Facebook pages here on Secord.

While these rumors have been debunked several times, the perpetrators of these false statements continue to purposely "stir the pot" to cause more confusion, frustration, and anger among their neighbors.

We reviewed the Milestones and Timeline. We have watched this build over the previous updates.

The two areas outlined in yellow:

To the left indicates what was needed to secure an EGLE permit to begin construction.

To the right what is required to receive an EGLE permit to fill Secord Lake.

The key takes away - - engineering and construction meet EGLE requirements to allow the lake to fill when completed. And we are closer to the end than the beginning.

We provided an update of the ongoing efforts of members of the Secord Lake Association to help seek additional support and funding to help the FLTF reduce assessment costs to ALL.

A bit later we will outline areas where you can help.

DAM	SUSPENSION DATE AND DESCRIPTION
Secord	July 2024 Shortly after the completion of the auxiliary spillway and stabilization of the primary spillway
Smallwood	August 2024 After auxiliary spillway is complete and the primary spillway is stabilized
Edenville	May 2024 Phase V (final phase) of the Edenville Dam, planned to start by May (pending permit), is now delayed until financing September 2024
	After completion of the current embackment improvement project (Phase IV)
Sanford	December 2024
	After completion of the current east side work

### Secord Suspension - July

- Coffer dam in place, pour select concrete in the primary spillways to stabilize it.
- Divert water flow through new Auxiliary spillway.
- Water level at the dam projected to rise 1 foot.
- Some gently sloped shorelines / sand bars may see water move up to 4 feet closer to shore.
- Ready for Primary Spillway / New Gates when work resumes.

### What is the Heron Cove Association Appeal?

- HCA legal appeal indicates all work on Secord dam should not have started.
- The HCA legal appeal seeks to terminate and redesign the special assessment district.
- The HCA legal appeal indicates there is no benefit to property values should the lake not be returned.
- HCA is an organization that states it only cares for "the general welfare of its members." It does not address the well-being of our community at large.

# NO Confidence in Heron Cove Path Forward for Secord Lake

- The HCA has no plan to restore Secord Lake.
  - $\mbox{ \ \ }$  The only plan is to attempt to invalidate the capital/construction SAD.
- The HCA president has stated that they are looking to have the State of Michigan "step in and stop this dramafest."
  - In Michigan for an appropriation to pass there must be agreement from a majority in the House (110 people); Senate (38 people) and the Governor.

This table indicates when construction on Secord is expected to suspend and at what point in the project for stabilization purposes.

We reiterated while Secord is projected to suspend in July, the other dams will suspend at intervals as work is completed to stabilize those structures for construction suspension.

The current plan is for Secord to be suspended with the coffer dam in place with water diverted through the new auxillary spillway. We will see a modest rise in water levels when this phase is complete.


As we discussed at the meeting, our comments were consistent with this written overview.
